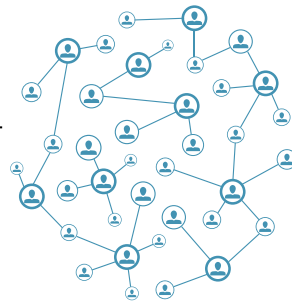

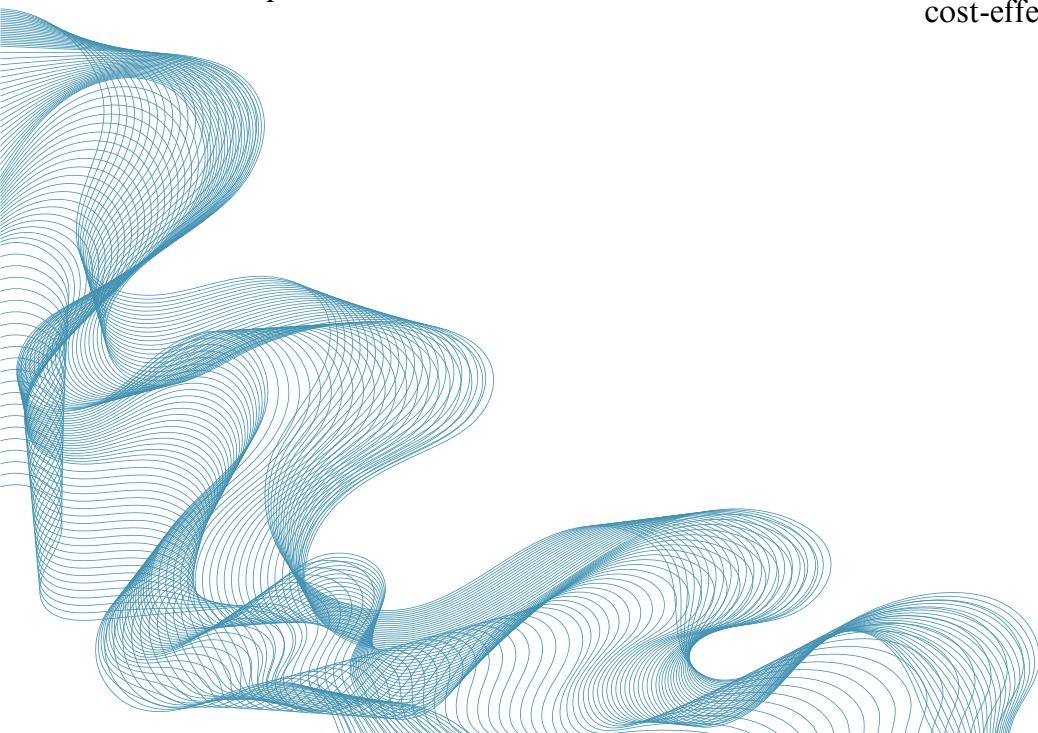

Membership Eligibility

Membership is open to corporate entities based solely in Mauritius. Eligible entities must be primarily or substantially engaged in providing services within the financial services industry, either professionally or as representatives of any sub-sector within the industry.

Membership Fees

The entrance fees payable by each Member is at USD 500.

Annual fee, depending on the category of the members as set out below:
